Streamline your B2B community

Businesses which implement projects involving EDI and the exchange of commercial documents often have a greatly varied pool of business clients, users, and recipients, many of which are not technologically prepared to exchange electronic data.

These recipients don't have the tools required to receive documents in an EDI-structured format. which means that senders must continue to manage a significant portion of their business information-exchange processes by conventional means (fax, email, post, etc.).

For these cases, EDICOM provides clients with an electronic document-publication service which the intended recipients can access via secure websites.

B&M: The solution that connects

Business Mail is a service aimed at enabling speedy and secure access for all types of electronic documents such as invoices, orders, payroll, etc.

The service is based on providing recipients with an online environment that has secure access using a web browser, from which users can consult, download, or print all types of documents made available by the different publishers.

This allows document publishers, generally large suppliers or distributors, to extend their reach and integrate smaller clients without EDI solutions into their B2B platform using a simple Business Mail publication.

B&M: The smart e-delivery service

- Integrated system: Business@Mail is fully integrated with a publisher's B2B platform and processes messages automatically.
- Multi-standard: The system can publish (EDIFACT. structured documents FACTURAE. UBL. etc.), non-structured documents, and graphics and images sent with the messages (JPG, PDF).
- Electronic signature: Allows documents to be published with electronic signatures, an ideal system for sending legally valid electronic invoices.
- Notification for recipient acknowledgement of receipt for sender: Recipients receive notification that documents are available, while senders can track their communications with different types of delivery notifications.
- Messages from multiple publishers: A single recipient can receive documents from several different senders using a single interface.
- Secure storage in accordance with the law: Documents published stored are Business@Mail for the period established by law, with all required security measures.

How it works



Senders can integrate 100% of outgoing transactions.

Recipients receive all types of electronic documents without the need for an EDI system.

DATA TRANSFER

The sender's ERP is connected by web services to the communications platform and the document data is transferred (invoice, order, etc.).

MAPPING & ELECTRONIC SIGNATURE

Data received are converted to the specified standard.

If unsigned invoices are received, they are signed using the service specified. Alternatively, if they are delivered with a signature, their authenticity and integrity are verified.

If the recipient of a document has the correct infrastructure or system in place, the document is sent directly.

If this is not the case, the document is sent via the Business Mail service

PUBLICATION

Documents are published using the Business Mail service. Document images (PDF, JPG, etc.) sent with the data or generated online with the publisher's personal format are also published in this manner.

NOTIFICATION FOR RECIPIENT Business Mail notifies the recipient by email when

documents are made available on the portal.


