Successful companies today have to exchange all data electronically with all business partners in order to live successful, fast and efficient business processes that make my company more successful than the competition.


When connecting my business partners electronically, it is crucial that the connection time is very short and the effort required is minimal in order to be able to scale sustainably.





Mandatory e-invoicing in Germany intensifies the pressure for all companies to integrate their business partners electronically.



Phase 1: from 1 January 2025, companies must be able to receive ZUGFerd from 2, UBL2.1 and CII

Phase 2: from 1.1.2026, companies with a turnover of €800k or more must be able to send ZUGFerd from 2, UBL2.1 and CII (no paper / no ZF1 / small amounts and tickets excluded).


Phase 3: Notification to central location by shipper within <6 days
Depending on the reporting system in Germany, which has yet to be defined (as of today, it has not been defined).
Today it is unclear whether the EU will provide a reporting system before or after Germany.

The eDocument Service is fully e-invoicing capable and can ensure that your company is e-invoicing compliant from 01.01.2025.

Further e-invoicing phases in 2026 and the later reporting obligation from vss. 2027 will be fully covered by our service.
